TOP PRO-CATHOLIC WINS

2021-22 Legislative Session

RELIGIOUS LIBERTY

- Religion is Essential: provides that churches are essential businesses and must remain open.
- Medical Conscience Rights: defends the individual rights, consciences and choices of religious medical professionals.

RESPECT FOR LIFE

- SC Heartbeat: bans abortions at the detection of a fetal heartbeat or at 6 weeks post conception.
- Real Alternatives: \$2.4 million to provide a statewide support program that promotes alternatives to abortion.
- Safe Haven for Infants: provides a safe, legal option to abandonment for babies up to 60 days old.
- St. Clare Home: \$200 thousand to fund Catholic home for mothers facing crisis pregnancies.
- Ad-hoc Committee: committee to deliberate laws after ruling on Dobbs v. Jackson Women's Health Organization.

PRO-FAMILY

- Paid Family Leave: entitles full-time state employees to 12 weeks of paid parental leave for childbirth or adoption.
- © Child Welfare Protection: protects faith-based adoption or foster-care providers from government discrimination.
- Foster Kin Reform: allows for displaced child to be placed in loving home of extended family or friends.

HUMAN PERSON

- Save Women's Sports: prohibits biological males from competing in girl's sports.
- Vaccine Mandate: protects individual's conscience objections to vaccines.

POOR & VULNERABLE

- Employment First: ends subminimum wage practices and promotes inclusive employment for disabled employees.
- Protection for Financial Exploitation: protects elderly from unfair banking practices and financial exploitation.
- Medicaid Expansion: extends coverage from 60 days to 12 months postpartum for new and expecting mothers.
- Lunch Vouchers: prohibits schools from discriminating against free and reduced lunch students.

EDUCATION

- Exceptional SC: program restructuring to increase funding for special needs students in non-public schools across SC.
- SC Highschool League: prevents discrimination against non-public school competition in sports.
- First Steps: provides pre-kindergarten non-public school choice options in all 46 counties in SC.
- COVID Relief: \$34 million in funding to Catholic schools serving diverse populations in SC.

Advocate for life-affirming laws, including anti-death legislation and support for mothers facing crisis pregnancies

02 POOR & VULNERABLE

Reform laws to curb human trafficking, predatory lending, and expand Medicaid and social services

Secure drivers licenses, identification cards, and fair and legal pathways to citizenship

04 EDUCATION

Promote parent driven school choice initiatives, home-school tax-credits, and special needs scholarships

05 PRO - FAMILY

Champion family-centric laws, adoption and child welfare protection, and legislation affirming human dignity
